**[PROPOSED] ORDER GRANTING

1 The matter before the Court is Intervenor CNET Networks, Inc.'s ("CNET") Motion for  
2 Leave to Intervene and To Unseal Hearing Transcript and Other Documents.

3 The Court has considered said motion and all papers in support and opposition thereto  
4 and, finding good cause, hereby grants CNET's motion in part and denies the motion in part as  
5 follows:

- 6 • CNET's Motion to Intervene in this action for the limited purpose of addressing its  
7 Motion to Intervene and to Unseal the June 23, 2008 hearing transcript is  
8 GRANTED;
- 9 • CNET's Motion to Unseal a redacted version of the June 23, 2008 hearing  
10 transcript regarding Facebook's Confidential Motion is GRANTED. The parties  
11 shall provide to the Court by July 9, 2008, a joint-proposed, redacted form of the  
12 June 23, 2008 hearing transcript with declarations supporting the reasons the  
13 proposed redacted information should remain sealed;
- 14 • CNET's Motion to Unseal documents previously sealed by this Court, the Court in  
15 Massachusetts, and the Superior Court is DENIED.
