13 I, Sean F. O'Shea, declare as follows:

14 1. I am a member of the law firm of O'Shea Partners LLP, 90 Park Avenue, New  
15 York, New York 10016, counsel for Cameron Winklevoss, Tyler Winklevoss and Divya  
16 Narendra (the "Intervenors") and counsel for Defendant ConnectU, Inc. in the above matter.

17 2. I make this Declaration in support of the Intervenors' Motion to Shorten Time  
18 Pursuant to Local Rule 6-3.

19 3. ConnectU, Inc. intends to appeal the Court's July 2, 2008 Judgment Enforcing  
20 Settlement Agreement. The time for filing the Notice of Appeal of that Judgment expires on  
21 August 1, 2008.

22 4. The Intervenors, who are shareholders of ConnectU, Inc., wish to join in the
