**ADMINISTRATIVE REQUEST OF  
 CAMERON WINKLEVOSS, TYLER  
 WINKLEVOSS AND DIVYA NARENDRA  
 FOR PERMISSION TO:**

- (1) **FILE A PARTIALLY-SEALED ADMINISTRATIVE REQUEST TO PAY LIENHOLDERS AND COMPLETE THE EXCHANGE OF CONSIDERATION PURSUANT TO CIVIL L.R. 79-5(c);**
- (2) **FILE AN OVERSIZED BRIEF IN SUPPORT OF SAID REQUEST; AND**
- (3) **FILE THE SUPPORTING DECLARATION OF TYLER MEADE AND THE EXHIBITS THERETO UNDER SEAL PURANT TO CIVIL L.R. 79-5(b).**

1 Pursuant to Civil L.R. 7-11 and 79-5, Cameron Winklevoss, Tyler Winklevoss and Divya  
2 Narendra (the "Founders") respectfully submit this Administrative Request for leave to file: (a) a partially-  
3 sealed Administrative Request To Pay Lienholders And Complete The Exchange Of Consideration; (b) an  
4 oversized brief in support of this Administrative Request (*i.e.*, the publically available filing will be  
5 appropriately redacted); and (c) the supporting Declaration of Tyler Meade and attached exhibits entirely  
6 under seal.

7 The Founders' Administrative Request To Pay Lienholders And Complete The Exchange Of  
8 Consideration contains a detailed discussion of the financial terms of the confidential settlement that this  
9 Court ordered enforced. It also includes other confidential information, such as the decision in a related  
10 arbitration and amounts to be paid to former counsel. The Founders propose filing a public version of this  
11 brief that redacts such confidential information, and a sealed unredacted version pursuant to Civil L.R. 79-  
12 5(c).

13 The supporting Declaration of Tyler Meade, and the exhibits thereto, contain the same confidential  
14 information. Since this declaration cannot practically be redacted, the Founders seek leave to file it  
15 entirely under seal pursuant to Civil L.R. 79-5(b).

16 This Court has previously directed that information relating to the financial terms of the settlement  
17 be filed under seal. *See, e.g.*, Dkt. 473, 632. This request is consistent with those prior Orders.

18 Finally, the Founders request leave to file a brief in excess of the five page limit provided for in  
19 Civil L.R. 7-11. While the Founders' request is administrative in nature and appropriately handled by  
20 means of Civil L.R. 7-11, the relevant history is complex and requires additional pages to fully explain.  
21 The Founders respectfully submit that the additional pages will aid the Court and facilitate a prompt  
22 resolution of this issue.
