**[PROPOSED] ORDER AUTHORIZING

 TO:**

- (1) FILE A PARTIALLY-SEALED ADMINISTRATIVE REQUEST TO PAY LIENHOLDERS AND COMPLETE THE EXCHANGE OF CONSIDERATION PURSUANT TO CIVIL L.R. 79-5(c);**
- (2) FILE AN OVERSIZED BRIEF IN SUPPORT OF SAID REQUEST; AND**
- (3) FILE THE SUPPORTING DECLARATION OF TYLER MEADE AND THE EXHIBITS THERETO UNDER SEAL PURANT TO CIVIL L.R. 79-5(b).**

1 Pursuant to Civil L.R. 7-11 and 79-5, Cameron Winklevoss, Tyler Winklevoss and Divya
2 Narendra (the “Founders”) have submitted an Administrative Request for leave to file: (a) a partially-
3 sealed (*i.e.*, redacted) Administrative Request To Pay Lienholders And Complete The Exchange Of
4 Consideration; (b) an oversized brief in support of this Administrative Request; and (c) the supporting
5 Declaration of Tyler Meade and attached exhibits entirely under seal. This Court finds good cause to
6 grant these requests.

7 ACCORDINGLY,

- 8 1. The Founders shall file a partially-sealed (*i.e.*, redacted) version of their Administrative
9 Request To Pay Lienholders And Complete The Exchange Of Consideration as well as a
10 public redacted version consistent with the proposed briefs submitted to this Court for
11 review in conjunction with this Request;
- 12 2. The Founders are granted leave to file an oversized brief in support of their Administrative
13 Request To Pay Lienholders And Complete The Exchange Of Consideration; and
- 14 3. The supporting Declaration of Tyler Meade and the exhibits thereto may be filed under
15 seal.
