1 Pursuant to Civil L.R. 79-5, Plaintiffs Facebook, Inc. and Mark Zuckerberg request the  
2 Court order that portions of Plaintiffs' Opposition to Defendants Pacific Northwest Software and  
3 Winston William's Motion To Dismiss for Lack of Personal Jurisdiction ("Opposition"), and  
4 certain exhibits of the Declaration of Monte M. F. Cooper in Support Thereof ("Cooper  
5 Declaration") be filed under seal, based on this Miscellaneous Administrative Request, the  
6 supporting Declaration of Michael W. Trinh In Support of Plaintiffs' Miscellaneous  
7 Administrative Request To File Plaintiffs' Opposition To Defendants' Motion To Dismiss And  
8 Related Exhibits Under Seal ("Trinh MAR Decl."), and a [Proposed] Order, attached herewith.

9 Under Civil Local Rule 79-5, a document may only be filed under seal upon a showing of  
10 good cause.

11 Certain portions of the Opposition refer to or contain information that is confidential and  
12 proprietary to Plaintiffs, or personally identifiable information about third party individuals. *See*  
13 *Trinh MAR Decl.* ¶ 2. Other portions of the Opposition refer to or contain confidential  
14 information that has been designated by defendants pursuant to the Stipulated Protective Order in  
15 this case. *See Trinh MAR Decl.* ¶ 3. Plaintiffs are lodging herewith a redacted version of the  
16 Opposition. Accordingly, good cause exists to seal these portions of the Opposition.

17 Certain exhibits of the Cooper Declaration refer to or contain information that is  
18 confidential and proprietary to Plaintiffs, or personally identifiable information about third party  
19 individuals. *See Trinh MAR Decl.* ¶ 4. Certain exhibits of the Cooper Declaration refer to or  
20 contain confidential information that has been designated by defendants pursuant to the Stipulated  
21 Protective Order in this case. *See Trinh MAR Decl.* ¶ 5. Accordingly, good cause exists to seal  
22 those exhibits of the Cooper Declaration.

23 Accordingly, Plaintiffs respectfully request the Court order that certain portions of the  
24 Opposition and certain exhibits of the Cooper Declaration be filed under seal, as specified in the  
25 attached [Proposed] Order.
