1	WHEREAS, on March 21, 2007, Plaintiff Syscan, Inc. ("Syscan") filed an action
2	in the United States District Court for the Northern District of California against Defendants
3	Plustek, Inc. ("Plustek") and Futurewell Holding Limited ("Futurewell"), alleging, inter alia, that
4	Plustek and Futurewell are in breach of contract.
5	WHEREAS, pursuant to the Scheduling Order dated September 14, 2007,
