The Court, having reviewed the Stipulated Request for Order Extending the Deadline for Discovery submitted by the parties and for good cause appearing,

IT IS HEREBY ORDERED that the non-expert discovery deadline shall be extended from June 1, 2009 to August 3, 2009.

IT IS FURTHER ORDERED that the expert disclosure and discovery deadlines shall be extended as follows:

- a. On or before September 15, 2009, plaintiff shall disclose expert testimony and reports in accordance with Rule 26(a)(2), F.R.Civ.P.;
- b. On or before September 30, 2009, defendant shall disclose expert testimony and reports in accordance with Rule 26(a)(2), F.R.Civ.P.;
- c. On or before October 15, 2009, all discovery of expert witnesses pursuant to Rule 26(a)(4), F.R.Civ.P. shall be completed.

IT IS FURTHER ORDERED that all other dates/deadlines set forth in the Further Case Management Scheduling Order dated March 19, 2009 shall remain the same.
