8	Reply Filing Deadline January 6, 2009
9	Last Day for Hearing Dispositive Motions January 27, 2009 at 10:00 a.m.
10	Final Pretrial Conference March 17, 2009 at 1:30 p.m.

13	Any motions to compel fact discovery must be filed no later than seven court days after
14	the Fact Discovery Cutoff, and any motions to compel expert discovery must be filed no later
15	than seven court days after the Expert Discovery Cutoff. (See Civ. L.R. 26-2).
16	Furthermore, the parties shall comply with the court's Standing Order re: Pretrial
17	Preparation with respect to the timing and content of the Joint Pretrial Statement, and other
18	pretrial submissions. ¹
