16	Luis Vuitton Malletier, S.A. ("Plaintiff") brings this action against Akonoc Solutions,		
17	Managed Solutions Group, and Steven Chen (collectively, "Defendants") for alleged trademark		
18	infringement. Before the Court is Plaintiff's Motion for Leave to File a First Amended Complaint.		
19	(hereafter, "Motion," Docket Item No. 64.) Due to the Court's unavailability, the motion is noticed		
20	for a hearing on September 8, 2008; thus, Defendants' obligation to file their opposition is not yet		
21	due.		
22	Plaintiff's proposed amendment modifies a single paragraph in the Complaint; the		
23	modification merely adds the names of the web sites alleged to have sold infringing products.		
24	(Motion, Ex. A.) Since the proposed amendment does not modify any substantive allegations or add		
25	additional parties, the Court finds good cause to GRANT Plaintiff leave to amend without further		
26	briefing or a hearing. See Civ. L.R. 7-1(b). On or before August 4, 2008, Plaintiff shall file its		
27	Amended Complaint as a separate docket entry.

The parties have also filed a Stipulation requesting a continuance of the Preliminary Pretrial Conference currently scheduled for September 8, 2008. (See Docket Item No. 66.) The Court DENIES the parties' Stipulation. The Preliminary Pretrial Conference will remain on **September 8**, unless otherwise ordered by the Court due to certain developments in the case.
