On March 14, 2011, Plaintiff filed a motion to compel Defendant to respond to certain interrogatories. Docket No. 169. However, the Court does accept the parties’ stipulated briefing schedule for the motion. After receiving these papers, the Court will rule on Plaintiff’s motion in due course. Should the Court find that oral argument is necessary, it will set a hearing date.
