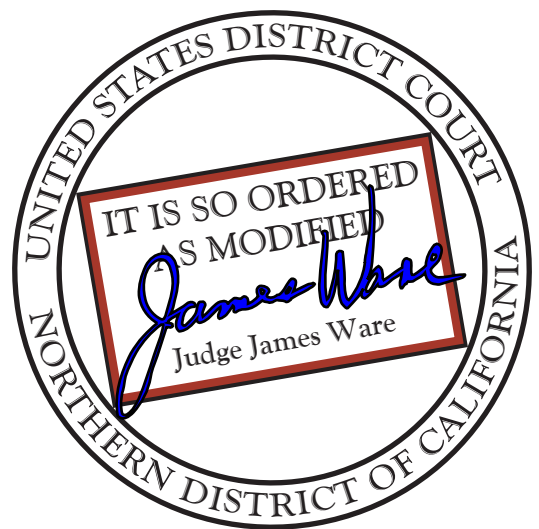

**STIPULATION AND [Proposed]  
 ORDER VACATING PRETRIAL  
 SCHEDULE AND SCHEDULING CASE

 19 Counsel for the parties participated in a mediation conference call with the court-  
 20 appointed mediator. Plaintiff's counsel has advised that he anticipates filing either a dismissal of  
 21 the action or a motion to withdraw as counsel within the next two weeks. In order to allow for  
 22 these matters to be resolved without additional unnecessary expense (particularly the cost of  
 23 experts), the parties, through their counsel of record HEREBY STIPULATE AND REQUEST  
 24 that the current pretrial schedule, including but not limited to the deadlines for mediation and  
 25 disclosure of experts, be vacated. The parties further request that a further case management  
 26 conference be scheduled in approximately 60 days so that, if the case has not been dismissed, a  
 27 new schedule can be set.
