1 This motion came on regularly for hearing on the motion of Girard Gibbs LLP and Law Office
2 of Damian R. Fernandez for an order appointing these firms as interim co-lead class counsel for the
3 plaintiff class pursuant to Rule 23(g) of the Federal Rules of Civil Procedure. After carefully
4 considering the applications of counsel, and the requirements of Rule 23(g)(1), the Court concludes that
5 the Girard Gibbs and Fernandez law firms are "best able to represent the interests of the class." Fed R.
6 Civ. P. 23(g)(2).

7 As demonstrated by their application, these two firms meet all of the standards set forth in Rule
8 23(g)(1). They have demonstrated exemplary work in identifying and investigating potential claims in
9 the action and they are experienced in the handling of complex consumer protection,
10 telecommunications, and antitrust class actions, including cases concerning similar facts and legal issues
11 that will be at issue in this case. In addition, these two firms have extensive knowledge in the applicable
12 law and they have appropriate resources to properly represent the class.

13 The motion is granted, and the law firms of Girard Gibbs LLP and Law Office of Damian R.
14 Fernandez are hereby appointed interim co-lead counsel for the plaintiff class pursuant to Rule 23(g).
