MOTION TO CHANGE DISCOVERY
DEADLINES**

Defendant Source Medical Solutions, Inc., has moved to extend several discovery deadlines because it needs additional time to complete important depositions and to prepare rebuttal expert witness reports. The Court has reviewed Defendant's motion and Plaintiff's opposition and finds that an extension is warranted. Accordingly, the following deadlines are changed for both parties:
