Sealing is requested because plaintiffs reportedly claim that the information in question is confidential. Plaintiffs, however, have not filed a declaration establishing that the information is sealable as required by Civil Local Rule 79-5. Although the information in question could be made a part of the public record, see Civ. L.R. 79-5(d), the court will give plaintiffs another opportunity to explain why sealing is warranted. Accordingly, **no later than October 19**, **2009**, plaintiffs shall file declaration(s) by appropriate person(s) establishing that the designated information is sealable.
