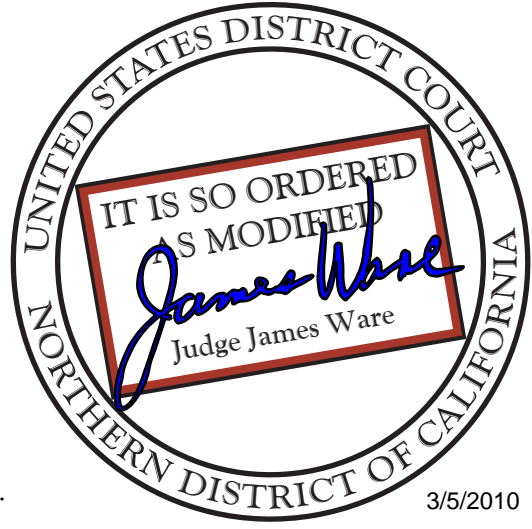

18 **STIPULATION AND [PROPOSED] ORDER REGARDING HEARING**  
 19 **ON LEAD PLAINTIFFS' MOTION FOR CLASS CERTIFICATION**

1           WHEREAS, by Order dated October 1, 2009, the Court scheduled a hearing on  
2 Lead Plaintiffs' motion for class certification for April 26, 2010 at 9:00 a.m.;

3           WHEREAS, on December 11, 2009, Lead Plaintiffs filed their motion for class  
4 certification;

5           WHEREAS, the parties have since been and are presently engaged in discovery,  
6 including discovery concerning Lead Plaintiffs' motion for class certification;

7           WHEREAS, Defendants' oppositions to Lead Plaintiffs' motion for class  
8 certification are currently due on March 15, 2010, and Lead Plaintiffs' reply in further support of  
9 the motion is currently due on April 12, 2010;

10           WHEREAS, the lead attorney for Defendant Maxim Integrated Products, Inc.  
11 ("Maxim") is currently defending a motion to enjoin a merger transaction in another matter,  
12 captioned *Miller, et al. v. Kinzel, et al.*, Case No. 2009-CV-1069 (Ohio Ct. Comm. Pl.) (the  
13 "Ohio Action"), that, pursuant to a court order issued on February 22, 2010, has been scheduled  
14 for an evidentiary hearing on March 10, 2010;

15           WHEREAS, as a result of the scheduling of the evidentiary hearing in the Ohio  
16 Action, the lead attorney for Maxim is presently and will remain engaged in extensive expedited  
17 discovery and briefing in the Ohio Action through March 10, 2010;

18           WHEREAS, in light of the significant time demands attendant to Maxim's lead  
19 attorney's other matter over the next several weeks, Maxim's counsel has suggested to Lead  
20 Plaintiffs' counsel a short 10-day extension of the current briefing schedule, whereby Maxim's  
21 opposition to Lead Plaintiffs' motion for class certification would be filed on March 26, 2010  
22 and Lead Plaintiffs' reply in further support of the motion would be filed on April 23, 2010;

23           WHEREAS, Lead Plaintiffs' counsel has indicated that they are amenable to such  
24 a schedule;

25           WHEREAS, to accommodate this desired schedule, and to afford the Court  
26 sufficient time to review the parties' submissions, the parties have agreed, subject to the approval

1 of the Court, to continue the April 26, 2010 hearing on Lead Plaintiffs' motion for class  
2 certification to May 10, 2010; and

3 WHEREAS, there has been no prior request to continue the hearing on Lead  
4 Plaintiffs' motion for class certification;

5 IT IS HEREBY STIPULATED AND AGREED, by and between the undersigned  
6 counsel, that the hearing on Lead Plaintiffs' motion for class certification presently scheduled for  
7 April 26, 2010 shall be continued to **May 24, 2010 at 9:00 AM**. The briefing schedule shall remain unchanged.


