23 **TO THIS HONORABLE COURT:**

24 By and through their counsel, Plaintiff J&J Sports Productions, Inc., and
25 Defendants Jose Edward Orozco, Sandra Orozco, and Goosetown, Inc. hereby agree,
26 stipulate, and respectfully request that this Honorable Court continue the ADR
27 deadline in the above entitled action from October 20, 2008 to December 31, 2008.
28 This brief extension of time is mutually requested for the following reasons.

1. Defendants Goosetown, Inc. has only recently responded to the
complaint plaintiff filed in the instant action. Specifically, Defendant

1 Goosetown, Inc. filed its answer on Tuesday, October 7, 2008; three days ago.

2 2. As of this writing, there has been no Case Management Conference
3 conducted in the action. The initial Case Management Conference, originally set for
4 August 15, 2008 at 10:30 AM was continued to October 31, 2008. As a result there
5 has been no scheduling order from the Court.

6 3. Because two original defendants were only recently dismissed and
7 another original defendant only recently answered, the parties have withheld
8 commencing discovery until the disposition of the defendant parties was fully
9 clarified.

11 4. Prior to conducting any arbitration in this action, the parties require
12 discovery on several issues central to the various claims and defenses of the parties.

13 5. The assigned arbitrator in this action is agreeable to the ADR extension
14 proposed by counsel for the plaintiff and answering defendants. Specifically, on
15 October 9, 2008 the undersigned counsel and arbitrator John Boos mutually cleared
16 Tuesday, December 16, 2008 at 12:30pm as the new date and time to conduct the
17 arbitration in this action.


