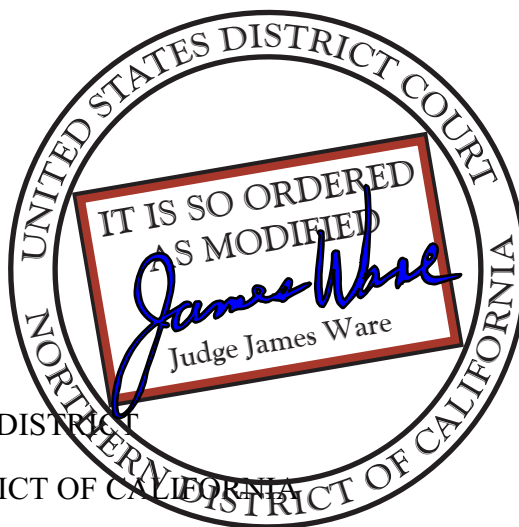




1 **\*\*\* ORDER \*\*\***
