**STIPULATION REGARDING TIME FOR
 AMENDMENT OF PLEADINGS**

[Civil L.R. 7-12]

22 Advanced Micro Devices, Inc. and ATI Technologies, ULC (collectively, “AMD”), and
 23 Samsung Electronics Co., Ltd.; Samsung Semiconductor, Inc.; Samsung Austin Semiconductor,
 24 LLC; Samsung Electronics America, Inc.; Samsung Telecommunications America, LLC;
 25 Samsung Techwin Co., Ltd.; and Samsung Opto-Electronics America, Inc. (collectively,
 26 “Samsung”) jointly submit this Stipulation regarding the extension of a previously agreed-upon
 27 deadline for the amendment of pleadings.
 28

1 The Joint Case Management Statement And [Proposed] Order filed by the parties on May
2 20, 2008, and the Subsequent Joint Case Management Statement And [Proposed] Order filed by
3 the parties on January 13, 2009 proposed that the last day to amend the pleadings be February 27,
4 2009.

5 The parties are continuing to meet and confer regarding proposed amendments to the
6 initial pleadings in this case.

7 The Court's scheduling orders have not set a deadline for the amendment of pleadings.

8 Pursuant to Civil Local Rule 7-12, IT IS HEREBY STIPULATED AND AGREED, by
9 and between AMD and Samsung that:

10 1. The last day for a party to amend its pleadings shall be March 11, 2009.

11 2. Any party seeking leave to amend its pleadings after March 11, 2009 shall first be
12 required to show good cause for modifying the schedule pursuant to Federal Rule of Civil
13 Procedure 16(b).

14 3. Any motions for leave to amend pleadings filed on or before March 11, 2009 shall
15 be deemed to be made within the Court's schedule and shall not be subject to the good cause
16 standard of Federal Rule of Civil Procedure 16(b).

17 4. In the event any party moves for leave to amend its pleadings, a party opposing
18 that motion shall not argue that the extension of time contemplated by this Stipulation constitutes
19 or contributes to a prejudicial delay in seeking leave to amend by the moving party.
