**STIPULATED REQUEST FOR AN
 ORDER CONTINUING THE CASE
 MANAGEMENT CONFERENCE
 SCHEDULED FOR 9-19-08 TO 10-3-08
 AT 9:00 A.M.**

1 The Parties in this action hereby stipulate and agree to the entry of an Order continuing
2 the case management conference of September 19, 2008, to October 3, 2008, and in support of
3 the requested relief, state as follows:

4 1. On April 30, 2008, Plaintiff filed a multi-count class action complaint against the
5 Defendant in the Superior Court of California, County of Santa Clara, captioned *Jenna Goddard*
6 *v. Google, Inc.*, Santa Clara Superior Court, Case no. 08-CV-111658.

7 2. On May 30, 2008, Defendant removed this action to this Honorable Court. On
8 June 30, 2008, Plaintiff filed a motion to remand this action back to the Superior Court of Santa
9 Clara. Thereafter, the parties stipulated to an extension of time for Defendant to respond to
10 Plaintiff's motion to remand through August 29, 2008.

11 3. By Order dated July 7, 2008, the Court granted Defendant an extension of time to
12 August 29, 2008, in which to respond to Plaintiff's motion to remand; set September 5, 2008, as
13 the deadline for Plaintiff to reply in support of her motion; and set the motion down for hearing
14 on September 19, 2008, at 10:30 a.m.

15 4. On August 29, 2008, Defendant timely served Plaintiff's counsel with its response
16 in opposition to the motion to remand, along with several other related documents filed with the
17 Court on that day.

18 5. On September 4, 2008, the parties filed a stipulated request for an Order
19 extending the time, up to and including September 26, 2008, in which plaintiff may file a reply in
20 support of her motion to remand and to reset the hearing of September 19, 2008, to October 3,
21 2008. (See "Stipulation dated September 4, 2008," a true and accurate copy of which is attached
22 as Exhibit A).

23 7. By Order dated September 8, 2008, the Court granted the parties' stipulated
24 request and extended the time, up to and including September 26, 2008, for Plaintiff to reply in
25 support of her motion to remand, and reset the hearing of September 19, 2008, to October 3,
26 2008, at 9:00 a.m.

27 8. Although the hearing on Plaintiff's motion to remand has been reset to October 3,

1 2008, at present, a case management conference is scheduled for September 19, 2008.

2 9. In light of the Court's September 8, 2008, Order continuing the hearing on
3 Plaintiff's motion to remand, the parties request that the Court also continue the case
4 management conference of September 19, 2008, to October 3, 2008, at 9:00 a.m.

5 WHEREFORE, the Parties respectfully request this Court enter an Order continuing the
6 case management conference of September 19, 2008, to October 3, 2008, at 9:00 a.m., or any
7 date thereafter as is convenient for the Court.

8 IT IS SO STIPULATED.
