DECLARATION OF WILLIAM M. WALKER

I, William M. Walker, declare:

1. I am an attorney at law duly licensed to practice law in the State of California and before the United States District Court for the Northern District of California, and am a partner at Greenberg Glusker Fields Claman & Machtinger LLP, counsel of record for defendants StudiVZ Ltd. (“StudiVZ”), Holtzbrinck Networks GmbH (“Networks”) and Holtzbrinck Ventures GmbH (“Ventures”) (collectively, “Defendants”). I have personal knowledge of the facts set forth herein and, if called as a witness, could and would testify competently thereto under oath. This declaration is submitted concurrently with “Defendants’ Motion for Administrative Relief re: Requesting Status Conference to Consider Preclusive Effect of German Judgment Issued June 16, 2009 Against Facebook, and for a Related Stay of Proceedings.”

2. I graduated from the University of California, Davis in 1985 with a bachelor of arts degree in German literature. I speak and read German fluently. Since graduating from law school in 1988, I have had extensive experience advising German clients doing business in the U.S. and U.S. clients doing business in Germany, frequently in German.
