
26 I have received your request to waive service of summons in this action

5 waive any objections to the absence of a summons or of service.

6 I also understand that I, or the entity I represent, must file and serve an
7 answer or a motion under Rule 12 within 60 days from August 27, 2008, the date when
8 this request was sent. If I fail to do so, a default judgment will be entered against me or
9 the entity I represent.

18 **Duty to Avoid Unnecessary Costs of Service of Summons**

19 Rule 4 of the Federal Rules of Civil Procedure requires certain defendants to
20 cooperate in saving unnecessary expenses of serving a summons and complaint. A
21 defendant who is located in the United States and who fails to return a signed waiver of
22 service requested by plaintiff located in the United States will be required to pay the
23 expenses of service, unless the defendant shows good cause for the failure.

24 "Good cause" does *not* include a belief that the lawsuit is groundless, or that
25 it has been brought in an improper venue, or that the court has no jurisdiction over this
26 matter or over the defendant or the defendant's property.

27 If the waiver is signed and returned, you can still make these and all other
28 defenses and objections, but you cannot object to the absence of a summons or of service.

If you waive service then you must, within the time specified on the waiver form, serve an answer or motion under Rule 12 on the plaintiff and file a copy with the court. By signing and returning the waiver form, you are allowed more time to respond than if a summons had been served.
