1 Pursuant to Civil Local Rule 6-2, Plaintiffs and NVIDIA, through their counsel of record  
2 and Interim Lead Class Counsel for Plaintiffs, hereby jointly seek an order extending time to file  
3 the Revised Proposed Order for Preliminary Approval until September 14, 2010. Filed currently
