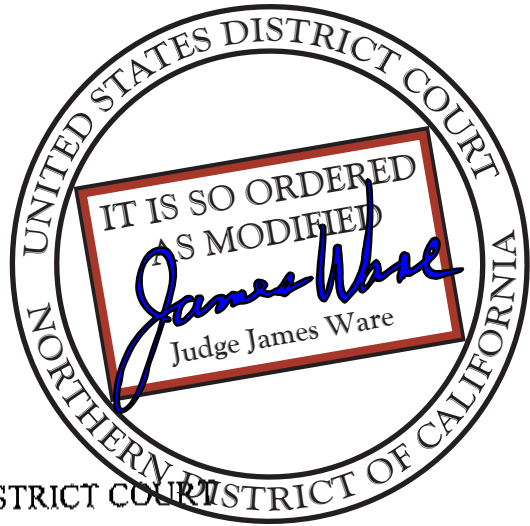

 20 ordinary breach of contract action in a court of competent jurisdiction.


