24 PLAINTIFF YAHOO! INC. ("Yahoo!") and DEFENDANT AMERICAN AIRLINES, INC.  
 25 ("American," and, collectively, the "Parties") by and through their counsel of record, hereby stipulate  
 26 and agree as follows:

27 WHEREAS, Yahoo! Inc. served its complaint in the above-entitled action on December 16,  
 28 2008.

WHEREAS, the Parties previously stipulated that American Airlines, Inc.'s response to  
 Yahoo!'s complaint would be due on February 4, 2009.

WHEREAS, Civil Local Rule 6-1(a) permits the Parties to stipulate to an extension of time to  
 answer or otherwise respond to the complaint.

1. The Parties agree and stipulate to an extension of time for American to respond to  
 Yahoo!'s complaint until March 6, 2009.

1 2. Neither this stipulation, nor its filing with the Court, constitutes an appearance by  
2 American in the above-entitled action.


3 3. Neither this stipulation, nor its filing with the Court, will be used by the Parties to alter  
4 any event or deadline already set by the Court, or any event or deadline set in the separate proceeding  
5 entitled *American Airlines, Inc. v. Yahoo! Inc. and Overture Services, Inc.*, Civil Action No. 4-08-  
6 CV-626-A (N.D.Tex.).

7 4. Neither this stipulation, nor its filing with the Court, will be used by the Parties to  
8 effect any future actions before this Court, or any currently pending or future actions in the separate  
9 proceeding, Civil Action No. 4-08-CV-626-A (N.D.Tex.).

10 5. Neither this stipulation, nor its filing with the Court, will be used by the Parties to  
11 limit Yahoo!'s rights in any way in this proceeding, or in the separate proceeding, Civil Action No. 4-  
12 08-CV-626-A (N.D.Tex.).
