1 2. On November 14, 2011, Defendant counsel began a jury trial in Santa Clara
2 County Superior Court before the Honorable Carrie Zepeda. The jury was impaneled on
3 Wednesday, November 16, 2011. The trial was set for three weeks, but was protracted because
4 the Judge Zepeda sits on the Small Claim Appeal Panel and cannot conduct trial on Fridays.
5 Also, the Thanksgiving Holiday delayed the trial even further. Therefore, Defendant's counsel is
6 not available to attend the second session of settlement conference before Magistrate Lloyd. Due
7 to her trial schedule, Defendant counsel is not able to properly prepare for the trial in this matter
8 and will not be able to attend the final pre-trial conference set on December 1, 2011.

9 3. Consequently, parties jointly request a continuance of the trial date in this matter
10 to a date that is mutually convenient to the Court and both parties after parties have an
11 opportunity to fully explore the settlement. Parties hereby request that the Court vacate the final
12 pre-trial conference and set a case management conference in this matter on December 9, 2011 to
13 set a new trial date.
