## **REQUEST FOR JUDICIAL NOTICE**

Quebecor World Arcata Corporation ("Quebecor") hereby requests the Court to take judicial notice of Exhibit 2 (Cleanup and Abatement Order No. 5-00-712, Regional Water Quality Control Board, October 6, 2000, dated October 6, 2000) attached to the accompanying Declaration of William D. Wick, which is incorporated herein by reference. This request is made pursuant to Rule 201 of the Federal Rules of Evidence and the authorities cited below.

Federal Rule of Evidence 201(b) provides that a court may take judicial notice of a fact "not subject to reasonable dispute in that it is either (1) generally known within the territorial jurisdiction of the trial court or (2) capable of accurate and ready determination by resort to sources whose accuracy cannot be reasonably questioned." Exhibit 1 attached to this request is a true and correct copy of an Order issued by the Regional Board and is public record. The contents of each of this document is a matter of general knowledge within the territorial jurisdiction of this Court and are not reasonably subject to dispute. Therefore, this Court can and should consider them in deciding Quebecor's Motion.
