
This law firm represents ASKCS.COM Inc. in the above entitled case as local counsel in the United States District Court for the Northern District of California.

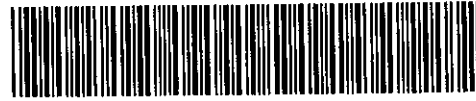
