**“transmit . . . to at a plurality of subscriber receiving stations” is indefinite**

- There is no way to tell how the claim was intended to read
  - “transmit to ~~at~~ a plurality of subscriber receiving stations”?
  - “transmit to at least one of a plurality of subscriber receiving stations”?
- The Court cannot correct the error, as it would be “required to guess as to what was intended.” *Novo Indus.*, 350 F.3d at 1358
