Dear Brandon:

I write in response to your letter dated March 26, 2008.

First, your letter mischaracterizes our agreement to limit YouTube's subpoena to BayTSP. During our telephonic meet and confer on January 30, 2008, YouTube agreed that, notwithstanding the language in its subpoena, the following categories of documents: (1) documents related to BayTSP's clients that are not named plaintiffs in the YouTube litigations, with the exception of relevant Viacom entities; and (2) BayTSP's source code, firm ware, computer programs and algorithms, are not called for under the subpoena. The parties further agreed that BayTSP will not object to the service of a subsequent subpoena requesting these documents on the basis that the second subpoena is duplicative of the current subpoena and without prejudice to YouTube to issue a subsequent subpoena requesting the excluded categories of documents.

When BayTSP sought to memorialize the above agreement, it defined the relevant Viacom entities as Viacom's subsidiaries, of which there are approximately 470. But YouTube stated that the term "subsidiaries" was ambiguous and suggested replacing the term "subsidiaries" with the term "Viacom-related entities". YouTube then refused to clarify what entities constituted Viacom-related entities. Instead, you requested that we provide you with a master list of Viacom subsidiaries and a list of Viacom entities that hold or distribute content. We provided such lists to you on February 20, 2008. Moreover, because BayTSP's business is to work with clients to ensure that their assets are tracked, secured and protected from Internet piracy, we suggested limiting BayTSP's production to those Viacom entities that hold or distribute content. For your convenience, I enclosed herein a copy of our February 15, 2008 e-mail correspondence and my February 20, 2008 email attaching the aforementioned lists.

YouTube never stated whether the production of documents relating to the entities in either list would satisfy BayTSP's obligations under the subpoena. Although the search for and production of documents relating to approximately 470 Viacom entities in addition to the named plaintiffs is burdensome, BayTSP never refused on this ground to produce documents relating to these entities. In an effort to resolve this issue so that BayTSP can move forward with the document production, BayTSP is willing to collect documents relating to those Viacom entities to which YouTube seeks the production of documents. Please provide a list of Viacom entities to which YouTube seeks the production of documents by April 5, 2008.

Second, we repeatedly told you, as documented in our letters dated February 15, 2008 and February 27, 2008 (which I enclose herein) that BayTSP does not possess copies of the takedown notices and that it would impose an undue burden upon BayTSP, a non-party, to create the takedown notices from its proprietary database. We further expressed the need to reach agreement concerning confidentiality in connection with the providing of any information relating to BayTSP's proprietary database. YouTube refused to confirm that it would compensate BayTSP for the burden imposed upon BayTSP to create the takedown notices or to address BayTSP's confidentiality concerns.

First, with regard to the list of Viacom entities to which BayTSP proposes to limit its response, we are in the process of obtaining such list from Viacom and hope to provide it to you by the end of next week.

Second, our timeline for production depends upon several matters we discussed. For example, it will depend on the format in which YouTube requests that BayTSP produce its documents. The timeline will also depend on what the parties can agree to with regard to the information related to the takedown notices. As you know, BayTSP does not have a copy of the takedown notices that were sent to YouTube. BayTSP does have information related to these notices in a proprietary database. As we discussed, we need to reach agreement concerning the handling of this information.



I write in response to your letter dated February 20 in which you requested that BayTSP produce responsive documents in the formats to which the parties to the litigation agreed, as set forth in the Amended ESI Discovery Plan. It is our understanding that YouTube will reimburse BayTSP for the expenses it incurs to copy and convert the responsive documents. Please confirm that YouTube will reimburse BayTSP for these expenses.

With respect to the takedown notices, as we have explained, BayTSP does not have copies of the takedown notices it sent to YouTube. We are confident that YouTube has a copy of each and every notice rendering YouTube's need to obtain them from BayTSP, even if it had copies, questionable given the burden. However, as we discussed we would be happy to continue our discussion concerning the information you want. Also, as we discussed the prerequisite to any such discussion is that YouTube would be willing to reimburse BayTSP for the time and effort spent creating documents from its proprietary database. Our preliminary investigations have indicated that trying to generate documents reflective of the takedown notices would take substantial time and effort. Further, since the database and its organization is confidential information of BayTSP, we would have to reach some agreement concerning confidentiality of the information provided before proceeding further. If you wish to continue these discussions please confirm that YouTube will reimburse BayTSP for expenses, time and effort incurred to create documents from its database.
