- Deadline for all expert discovery to be completed extended from January 7, 2011 to May 6, 2011;
- Deadline to hear all pretrial motions extended from January 7, 2011 to ~~May 13,~~ <sup>May 12,</sup> 2011;
- Deadline for filing joint pretrial statement extended from April 11, 2011 to August ~~12, 2011,~~ <sup>August 18, 2011.</sup>
- Pretrial conference continued from April ~~25,~~ <sup>28</sup> 2011 at ~~2:30pm~~ <sup>10:00 am</sup> to August ~~29, 2011~~ <sup>Sept. 1, 2011</sup> at 10:00 a.m.
- Trial extended from May 9, 2011 to September 12, 2011. at 9:00 a.m.
