18           2.       The parties, in violation of the Court's prior Case Management Order [Docket  
19 No. 10], have each filed separate Case Management Statements. *See* Docket Nos. 18, 21. These  
20 pleadings, filed as Docket Numbers 18 and 21, are STRICKEN. The parties are ORDERED to  
21 comply with the joint filing provisions of this Order.

22           3.       Defendant filed a letter with the Court, requesting to continue the Case Management  
23 Conference. In the future, such requests shall be filed as a stipulation, or if unable to obtain one,  
24 then as an administrative motion explaining why no stipulation was obtainable. *See* Civil Local  
25 Rule 7-11.
