("Apple") as "Confidential – Attorney Eyes Only" or "Confidential – Attorneys Eyes Only – Source Code" pursuant to the Amended Protective Order in this matter. See Declaration of Jennifer Liu In Support of Plaintiff Elan Microelectronics Corporation's Renewed Motion To File Papers Under Seal filed concurrently herewith. In accordance with Civil Local Rule 79-5, for these partially redacted documents, only minimum and necessary redactions are made to protect sealable information identified and confirmed by Apple. In addition, Elan states that Exhibits 3-6, 23-25, 27, 29-33, 35-37, 39-45, 47 to the Amended Liu Declaration constitute documents designated by Apple as "Confidential – Attorney Eyes Only" or "Confidential – Attorneys Eyes Only – Source Code" pursuant to the Amended Protective Order in this matter. These exhibits predominately consist of sealable information such that it may be appropriate to seal the entire document rather than requiring submission of a heavily redacted document that would not substantially further the policy of providing public access to, and understanding of, court proceedings. See id. Pursuant to the Court's May 11, 2011 Order Denying Elan's Motion to Seal Without Prejudice (Dkt No. 204), Elan states that it has met and conferred with counsel for Apple, and confirmed with Apple the sealable materials identified above which Apple believes there exists a good faith basis to permit sealing. Elan further states that the parties have given particularized consideration to each exhibit prior to requesting that it be sealed, either in its entirety or through reductions.

For the reasons stated above, the Court should grant Elan leave to file the above identified
