STIPULATION TO CONTINUE FACT  
 DISCOVERY CUTOFF DEADLINE  
 AND ORDER

17 Parties, through their respective counsel, stipulate to continue the deadline to complete  
 18 mediation as follows:

- 19 1. Plaintiffs filed their Complaint on May 6, 2009;
- 20 2. The Initial Case Management Conference was held on October 23, 2009;
- 21 3. Currently, this case is set for trial, if any, on November 1, 2010, with fact  
 22 discovery cutoff on June 30, 2010, and expert discovery cutoff on September 15, 2010.
- 23 4. Given counsel's trial schedule, parties are unable to schedule all the depositions  
 24 before the end of June. As such, parties agree and stipulate to extend the discovery deadline for 4  
 25 weeks until July 30, 2010.
- 26 5. This brief extension will not affect the other dates, as parties do not anticipate the  
 27 need for expert witness while the Court's scheduling order provides a 3-month expert discovery  
 28 until September 30, 2010.
