STIPULATION REGARDING EXTENSION OF TIME TO FILE MOTION FOR PRELIMINARY APPROVAL

CASE NO. 5:09-cv-02708-LHK

1           WHEREAS, on March 20, 2012, this Court entered an order requiring the parties to  
2 file a motion for preliminary approval or dispositive motion by April 6, 2012;  
3

4           WHEREAS, the parties have reached an agreement with respect to the relief to be  
5 made available to the Class and Subclass members, attorneys' fees and costs, and incentive  
6 awards to the Schulkens;

7           WHEREAS, the parties have exchanged drafts of a written Settlement Agreement,  
8 along with drafts of other materials to be submitted in support of the motion for preliminary  
9 approval, including a short form mail notice, claim form, and long form notice. Chase is also  
10 in the process of retaining a Claims Administrator to facilitate the notice, benefits to class  
11 members, and settlement website elements contemplated in the settlement, and to assist with  
12 improving the class notices and claim forms;  
13

14           WHEREAS, in order to finalize the settlement agreement and supporting materials,  
15 and the parties request an additional three weeks from the April 6, 2012 deadline to submit a  
16 motion for preliminary approval, extending the date to April 27, 2012;  
17

18           WHEREAS, the requested extension of the deadline to submit a motion for  
19 preliminary approval will not interfere with the preliminary approval hearing, which is  
20 scheduled for July 19, 2012; and

21           WHEREAS, because the parties have reached a class settlement, they will not be  
22 filing dispositive motions and request that the remaining pretrial and trial dates be stricken.  
23 The parties' contemplated motion for preliminary approval will contain a request that the  
24 Court set dates relating to the settlement, including notice deadline, request for exclusion  
25 deadline, and the date for a final approval hearing.


