2 WHEREAS, on October 20, 2009, plaintiff Rudolf Zijdel (“Plaintiff”) filed a First
3 Amended Class Action Complaint (Docket No. 40);

4 WHEREAS, on November 3, 2009, defendant Thumbplay, Inc. (“Thumbplay”) filed a
5 Motion for More Definite Statement (Docket No. 46);

6 WHEREAS, on November 12, 2009, the Court denied the Motion for More Definite
7 Statement (Docket No. 53), and Thumbplay’s response to the Complaint is currently due on or
8 before November 30, 2009;

9 WHEREAS, pursuant to Local Rule 6-1(a), parties may agree to an extension of time within
10 which to answer or otherwise respond to a complaint, provided the change will not alter the date of
11 any event or any deadline already fixed by Court order;

12 WHEREAS, the parties have agreed to a 21-day extension of the time for Thumbplay to
13 respond to the Complaint;

14 WHEREAS, the extension proposed herein will not alter the date of any event or any
15 deadline already fixed by Court order; and

16 WHEREAS, the parties enter into this Stipulation in good faith and not for purposes of
17 delay;

19 counsel of record, that Thumbplay’s time to respond to the First Amended Complaint hereby is
20 extended for a period of twenty-one (21) days, to and including December 21, 2009.
