Patito filed a complaint in the Santa Clara Superior 20 Court alleging violations of the Truth in Lending Act, unlawful business practices, unfair and 21 fraudulent business practices, fraudulent omissions, quiet title action, rescission based on fraud, 22 unfair debt collection practices, breach of fiduciary duty, breach of contract, breach of the 23 covenant of good faith and fair dealing, and declaratory and injunctive relief. 24 On August 5, 2009, the action was removed to this Court. On August 17, 2009, 25 Defendants Central Mortgage Company ("CMC") and Mortgage Electronic Registration 26 Systems, Inc. summary judgment. Subsequently, Patito filed a motion for voluntary withdrawal of her claims. Because of an administrative error, the action was dismissed notwithstanding the pendency of the motion for summary judgment. The Court set aside the dismissal in order to address the motion. Patito does not oppose the motion. Having reviewed the moving papers, the Court concludes that the motion is well-taken. Accordingly, the motion for summary judgment is GRANTED. IT IS SO ORDERED.
