**STIPULATION AND [PROPOSED]  
ORDER CONTINUING CASE  
MANAGEMENT CONFERENCE TO  
MARCH 12, 2010**

1                    **STIPULATION REGARDING THE CASE MANAGEMENT CONFERENCE**

2                    WHEREAS, the Case Management Conference in this action was initially  
3 scheduled for February 19, 2010 at 10:30 a.m. before Judge Jeremy Fogel pursuant to  
4 the *Clerk’s Notice* entered on January 12, 2010 (Dkt. 18).

5                    WHEREAS, the Case Management Conference was continued to February 26,  
6 2010 at 10:30 a.m. before Judge Jeremy Fogel pursuant to the *Clerk’s Notice* entered on  
7 February 17, 2010 (Dkt. 38).

8                    WHEREAS, scheduling conflicts would make it difficult for the lead counsel of  
9 Defendant Google Inc. to attend a Case Management Conference on February 26, 2010,  
10 or a week later, on March 5, 2010.

11                    WHEREAS, the Court’s clerk has informed counsel for Defendant Google Inc.  
12 that the Case Management Conference could be rescheduled for March 12, 2010  
13 pursuant to a Stipulation entered by the Parties.

14                    NOW THEREFORE, Plaintiff Textscape LLC and Defendant Google Inc. (“the  
15 Parties”) hereby stipulate that the Case Management Conference shall take place on  
16 March 12, 2010 at 10:30 a.m. before Judge Jeremy Fogel in courtroom 3 on the 5th  
17 floor of the U.S. District Court, 280 S. First St., San Jose, California, or as otherwise  
18 directed by the Court.

19                    The parties have also agreed to amend the *Joint Case Management Conference*  
20 *Statement* filed on February 12, 2010 (Dkt. 36) and adjust the proposed case deadlines  
21 in view of the postponed Case Management Conference. An *Amended Joint Case*  
22 *Management Conference Statement* shall be filed forthwith.
