Dear Patrick:

TechCrunch's deposition took place yesterday, April 20, 2010. At it, we provisionally designated the transcript as "Confidential – Attorneys' Eyes Only." We will provide you with final designations for various portions of the transcript within 20 days, according to the procedure set forth in Paragraph 5.2(b) of the Stipulated Protective Order. Your written request this morning that we de-designate the entire deposition transcript by close of business today is contrary to Paragraph 5.2(b) and improper under Paragraph 6.2, requiring a voice-to-voice conference of counsel. At yesterday's deposition, Mr. Stern stated that Fusion Garage would "comply with the protective order to the letter with respect to this deposition." We trust this has not changed. We will be available to discuss any concerns that Fusion Garage may have about TechCrunch's final designations of testimony once we provide those designations pursuant to Paragraph 5.2(b).
