Dear Patrick:

I respond to your letter of Wednesday afternoon.

At the deposition I did not strive to identify orally every portion of the transcript that should be maintained as confidential. I recall at least three discussions. First was to designate the entire transcript as "confidential." Second was to elevate that designation to "highly confidential." Third was to give the deponent some assurance about questions that he was particularly concerned about by reminding him that we were designating the entire transcript highly confidential. I followed the standard process, as Claude insisted, and we shall continue to do so. It is not feasible for me to review the transcript at the moment for de-designation purposes because of other pressing business, such as organizing review of the 30,000+ pages of documents we just received from your firm.
