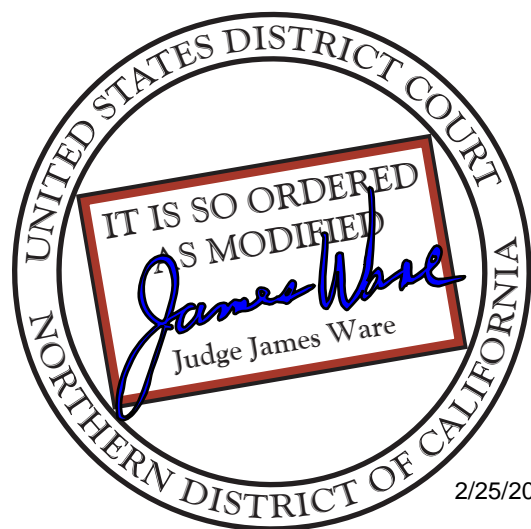

20 Pursuant to Civil L.R. 6-2 and 7-11 and Fed. R. Civ. P. 6(b), Plaintiff PixArt Imaging Inc.
 21 (“PixArt”) and Defendants Avago Technologies General IP (Singapore) Pte. Ltd., Inc., Avago
 22 Technologies ECBU IP (Singapore) Pte. Ltd., Inc., and Avago Technologies USA, Inc.
 23 (collectively “Avago,” and along with PixArt, “Parties”) jointly submitted a request that the
 24 Court enter an order setting the time for filing an Opposition to PixArt’s Administrative Motion
 25 to Consider Whether Cases Should Be Related (“Administrative Motion”) and extending the
 26 time for Avago to move, answer, or otherwise respond to PixArt’s Complaint For Declaratory
 27 Judgment (“Complaint”).

28 Having considered the Parties stipulated request and the declaration submitted in support

1 thereof, the Court hereby GRANTS the stipulated request and makes the following order:

2 For the reasons set forth in the stipulated motion and supporting declaration and for good
3 cause shown, the Court ORDERS that

4 the time
5 for Avago to move, answer, or otherwise respond to PixArt's Complaint For Declaratory
6 Judgment is extended to March 31, 2010.

7 PURSUANT TO STIPULATION, IT IS SO ORDERED.


