**ORDER DENYING MOTION FOR
CONTINUANCE, GRANTING MOTION
FOR TELEPHONIC APPEARANCE**

Presently before the Court is Objector Marek's Motion for Continuance or, in the Alternative, Motion for Telephonic Appearance.¹ In her Motion, Objector requests that the Court continue the Final Fairness Hearing on settlement set for February 7, 2011 at 9:00 a.m. to February 14, 2011 at 9:00 a.m. based on Objector's counsel's scheduling conflicts. (Motion at 1.) On January 25, 2011, Plaintiffs² and Defendant³ filed timely Oppositions.

Upon review, the Court does not find good cause to continue the February 7, 2011 Final Fairness Hearing. While Objector Marek states her counsel has a pre-existing commitment for the week of February 7, 2011, she does not cite to a specific conflict on the day of February 7, 2011. Moreover, Objector contends that her counsel is available to appear at the Final Fairness Hearing by phone.


