6		(vi) Overall annual operating budget of the organization as a whole and the specific Internet privacy or education program.
7		(vii) Amount received, if any, in contributions from Google, Inc. in 2010 independent of this Settlement.
8	(e)	Upon review of Class Counsel's submission, the Court shall issue Final Approval as to <i>cy pres</i> distribution, including the specific <i>cy pres</i> organizations and amount
9		distributed per organization. The final approval list of <i>cy pres</i> organizations may draw, but need not be drawn, entirely from the submission of nominations by Class
10		Counsel. The Court reserves the right to designate <i>cy pres</i> recipients who would reasonably benefit the Class through established Internet privacy education and
11		policy programs on its own motion.
