Important information about Google Buzz Class Action dated Tue, Nov. 2, 2010 at 3:30 pm states that Everyone in the U.S. who uses Gmail is included in the settlement. In a later notice, postmarked Dec 7, 2010, incentive awards will be distributed to organizations and to the selected Internet privacy organizations. Privacy is referring to withholding information from the class and changing the settlement.

To be part of any lawsuit about legal claims resolved in the settlement you must exclude yourself, not be excluded by somebody else. If you exclude yourself, you cannot object to the proposed Settlement. These statements are contradictory, and cannot both be true.

If you exclude yourself, you will not be bound by anything that happens in this action. The objection is what could happen! This statement sounds very threatening; look at the word "bound".
