21 Class Counsel hereby submit this Response to Class Member Megan Marek's Request for
22 Continuance or, in the Alternative, Request for Telephonic Appearance.

23 Ms. Marek seeks to continue the Final Approval Hearing in this matter set for February 7,
24 2011, to February 14, 2011. In support of this request, Ms. Marek states that her counsel, John W.
25 Davis, will be unable to attend the hearing due to prior commitments.

27 Class Counsel oppose the request to change the hearing date. The Final Approval Hearing is
28 for a proposed Settlement of a class consisting of more than 37 million members. Class Counsel and
