**ORDER DISMISSING APPEALS AS
MOOT**

Presently before the Court are Appellants' Appeals from the Bankruptcy Court's Memorandum Decision and Order on Motions to Determine Administrative Priority of Attorneys' Fees Claim.¹ Appellants appeal a ruling of the Bankruptcy Court refusing to treat this Court's award

1 of attorney fees to Appellants as a priority administrative claim, even though the losing party's claim
2 for attorney fees arising out of the same proceeding was treated as an administrative priority claim.²

3 A full statement of the facts of the underlying case can be found in the Court's December 11,
4 2008 Order Granting Plaintiffs' Motion for Summary Judgment.³ On January 30, 2009, the Court
5 entered judgment in favor of Plaintiffs and against Defendant ComUnity, declaring that certain
6 disputed funds were not assets of a bankruptcy estate, but instead belonged to participants in a Non-
7 Qualified Deferred Compensation Plan.⁴ On February 9, 2009, the Trustee filed a Notice of Appeal
8 to the Ninth Circuit.⁵ On April 24, 2009, the Court granted Plaintiffs' Motions for Attorney Fees,
9 but denied Plaintiffs' request that the Court adjudicate the priority of any costs or fees awarded.⁶ On
10 February 16, 2010, the Bankruptcy Court held that Plaintiffs' fee awards were not entitled to
11 priority.⁷ On March 4, 2010, Plaintiffs appealed the Bankruptcy Court's decision regarding the
12 priority of fee awards to this Court.⁸

13 On October 8, 2010, the Ninth Circuit reversed this Court's order granting Plaintiffs' Motion
14 for Summary Judgment and vacated this Court's "judgment and the order awarding Plaintiffs their
15 attorneys' fees."⁹ On May 2, 2011, the Court ordered the parties to file supplemental briefing to
16 explain whether the Appeals in No. C 10-00930 JW and No. C 10-00931 JW are moot, in light of the



1 Ninth Circuit’s October 8, 2010 opinion.¹⁰ On May 12, 2011, the parties filed a Joint Statement
2 contending that, whether or not the Appeals are moot, there “would be no useful function in
3 pursuing the Appeals before judgment is rendered in the underlying action, Case No. C 08-00201
4 JW,” and stating that the Appeals “should be held in abeyance . . . pending the entry of judgment in
5 the underlying action. (See Docket Item No. 38 at 2-3.)

6 Upon review, the Court finds that the Appeals are moot in light of the Ninth Circuit’s
7 opinion, which vacated this Court’s order awarding attorney fees to Plaintiffs. The Court rejects the
8 parties’ contention that these appeals should be held in abeyance pending the outcome of the 2008
9 underlying action. Now that the 2008 underlying action is proceeding to trial, its outcome may be
10 substantially different than the Court’s decision on summary judgment. Thus, it is premature to
11 speculate whether there would be an award of fees which would then be subject to a claim before the
12 bankruptcy court, and whether the bankruptcy court would make an adverse decision against
13 Appellants regarding priority, thus resulting in the need for appeals.

14 Accordingly, the Court DISMISSES the Appeals as moot. The Clerk shall close these files.
