1 WHEREAS, Defendants Google, Inc. and HTC Corporation (the “Defendants”)
2 filed a Motion to Dismiss the Consolidated Amended Complaint in this action on October 24,
3 2011 (Docket No. 113);

4 WHEREAS, the hearing on the Motion to Dismiss is set for February 3, 2012;

5 WHEREAS, Plaintiffs Mary McKinney and Nathan Nabors (the “Plaintiffs”) filed
6 an opposition to the Motion to Dismiss on November 7, 2011 (Docket No. 117);

7 WHEREAS, pursuant to Civil Local Rule 7-3(c), Defendants’ reply in support of
8 the Motion to Dismiss is due November 14, 2011;

9 WHEREAS, the parties have agreed that Defendants’ deadline for filing the reply
10 should be extended until November 28, 2011, and;

11 WHEREAS, this agreed extension “involves papers required to be lodged or filed
12 with the Court,” and a court order is therefore required under Civil Local Rule 6-1(b) to extend
13 the deadline;

15 stipulate to the following:

16 IT IS HEREBY STIPULATED that, subject to Court approval, Defendants
17 Google, Inc. and HTC Corporation shall have until November 28, 2011, to file a reply in support
