

1 Pursuant to Federal Rules of Civil Procedure 41(a)(1)(A)(i) and (B), Plaintiff FuzzySharp
2 Technologies Incorporated hereby voluntarily dismisses, without prejudice, its claims in this action
3 against Defendants NVIDIA Corporation, Dell Inc., and Matrox Inc. Separately, Plaintiff's counsel
