1 Pursuant to Civil Local Rules 7-12, Plaintiff Lift-U, a division of Hogan Mfg., Inc.
2 (“Plaintiff”) and Defendants Ricon Corp. and Westinghouse Air Brake Technologies Corporation
3 (collectively, “Defendants”), through their respective counsel of record, hereby state as follows:

4 1. By Order dated June 22, 2011 (Doc # 55), the Honorable Lucy H. Koh entered a
5 Minute Order and Case Management Order (“Case Management Order”).

6 2. That Case Management Order scheduled a tutorial for the Court for September 19,
7 2011 at 1:30 p.m. and a related patent claim construction and summary judgment hearing for
8 September 23, 2011 at 12:00 p.m., both to be held at the courtroom of Judge Koh.

9 3. In order to make appropriate presentations at both events, the parties anticipate

19 a projector table and technician table for such equipment into the
20 Federal courthouse and up to the courtroom of the Honorable Lucy H.
21 Koh on September 19, 2011 and on September 23, 2011.
