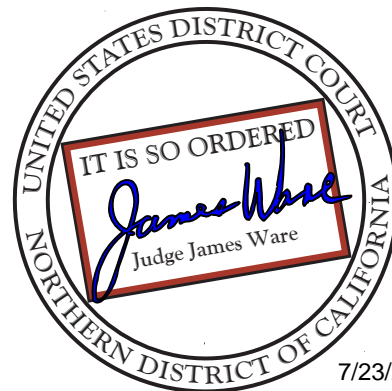

2 Defendant Morgan Hill Unified School District ("District") only;
