18 IT IS HEREBY STIPULATED by and between Plaintiffs Alma Clarisa Hernandez,
 19 Theresa Wallen and Ronald Moore (“Plaintiffs”) through their attorney of record, and
 20 Defendant Hashim Banglesh (“Defendant”) who is self-represented, that pursuant to Federal
 21 Rule of Civil Procedure 41(a)(2), Defendant Hashim Banglesh dba Sports Action be dismissed
 22 with prejudice from this action.

23 IT IS FURTHER STIPULATED between Plaintiffs and Defendant that this case has
 24 been settled as between them and all issues and controversies have been resolved to their
